**Eye contact**

Specific hazards arising from the chemical

: Extremely flammable aerosol. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. #### Personal precautions, protective equipment and emergency procedures

# For non-emergency personnel

#### Large spill
